

**NOTICE OF PASSING OF A ZONING BY-LAW  
BY THE CORPORATION OF THE MUNICIPALITY OF CENTRE HASTINGS**

**TAKE NOTICE THAT** the Council for the Corporation of the Municipality of Centre Hastings passed **By-law Number 2023-68 on the 1<sup>st</sup> day of November 2023** under the authority of Section 34 of the Planning Act, as amended.

**AND TAKE NOTICE** that any person or agency with appeal rights may appeal to the Ontario Land Tribunal in respect to the By-law by filing with the Clerk of the Corporation of the Municipality of Centre Hastings, not later than the 23<sup>rd</sup> day of November 2023, a notice of appeal setting out the objection to the By-law and the reason(s) in support of the objection and must be accompanied by the \$400.00 fee payable to the Minister of Finance. Only individual, corporation and public bodies may appeal a By-law to the Ontario Land Tribunal. A notice of appeal may not be filed by an unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or the group on its behalf.

**NO PERSON OR PUBLIC BODY** shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at a public meeting or written submissions to the council or, in the opinion of the Tribunal, there are reasonable ground to add the person or public body as a party.

**AN EXPLANATION OF THE PURPOSE AND EFFECT** of the By-law and a key map showing the location of the lands to which the By-law applies follows below. The complete By-law is available for inspection in the Clerk's Office during regular office hours.

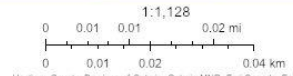
