# CIP GRANT SECTIONS

The CIP consists of the following:

- A Façade/Signage Improvement Loan and Grant Program
- An Accessibility Loan and Grant Program
- A Building Improvement Loan and Grant Program
- Building Permit Fee Grant



## COMMUNITY IMPROVEMENT PLAN GENERAL TERMS OF LOAN & GRANT PROGRAM

The applicant may choose to apply for either a Grant or Loan Program, or both simultaneously. The maximum amount that an applicant can receive in Grants and/or Loans for Improvements is capped for each financial incentive stream.

An applicant cannot apply for grants/loans in excess of the incentive cap, any applications requesting excess fund will be rejected.

Financial Incentive/ eligible criteria	Maximum Grant and/or Loan amount
FAÇADE AND SIGNAGE IMPROVEMENT GRANT/LOAN	\$2000 Maximum of 50% of total project cost
ACCESSIBILITY IMPROVEMENT GRANT/LOAN	\$3000 Maximum of 50% of total project cost
BUILDING IMPROVEMENT GRANT/LOAN	\$3000 Maximum of 50% of total project cost
PLANNING AND BUILDING PERMIT GRANT	\$1000 Maximum of 50% of total project cost
